



### Update on the TMA Stroke Project

In October, 2000, a report in *Journal of the American Medical Association* (JAMA)¹ describes a method for measuring clinical performance in several clinical scenarios. In myocardial infarction, stroke and atrial fibrillation, Texas physicians ranked at or near the bottom of the country. While there may be questions concerning the methodology and particular quality indicators chosen, there are still lingering questions concerning the routine care of stroke patients in Texas. In an attempt to reduce the morbidity and mortality due to stroke, the TMA Stroke Prevention Project was launched in 1994. Later with the addition of relatively non-controversial treatment recommendations, it became the TMA Stroke Project (TMASP). This model is being copied on a national level.

The TMASP is a joint effort of the TMA and the American Heart Association with generous unrestricted educational grants from DuPont Pharma, Glaxo-Wellcome and Genentech. The first two-hour talk addresses pathophysiology and prevention of stroke. The third hour is aimed at prevention of stroke secondary to atrial fibrillation, including instruction on the institution and maintenance of anticoagulant therapy. A fourth hour has recently been added to cover stroke as an emergency and includes the use of thrombolytics. A fifth hour on long-term care and rehabilitation is being developed and the original programs are being revised and updated. These programs are designed to be given in one-hour talks or in a complete symposium. The talks are given on request by a voluntary speaker's panel, many of whom are TNS members.

While the intended audience is primary care physicians such as family practice doctors and internists, talks have been modified to address clinical and medical record review rses, EMT's, medical students, residents and lay groups. Since 1996, 105 programs have been given to 3493 physicians and 855 non-physicians. It is hoped that this program will help improve the care of stroke patients in Texas, but the Stroke Project message needs to be given to more doctors across the state.

I would recommend that any of these CME programs be given for hospital staff meetings or other CME activities. The Stroke Project will send a speaker to programs on request. ### Bylaws Revison Suggested

In 1999 and 2000 the board of directors at Texas Neurological Society recognized the desirability of soliciting additional input from the membership through a variety of means. The underlying belief is that the increased representation to the board and the electoral process would help the Society to best represent the diversity of interests among the membership.

The bylaws committee was instructed to consult with <u>Davis' Rules of Order</u> (parliamentary guide), and to scrutinize appropriate bylaws of our sister societies representing medical disciplines within the Texas Medical Association. These were undertaken and the proposed bylaws changes which would create a nominating committee with increased membership representation is proposed for your consideration for vote at the annual meeting in 2001.

### Article II - Officers Section 3 - Nominations

Nomination of all officers shall be made by the Board of Directors acting as a nominating committee. Nomination may also be made from the floor.

New proposed wording:

A. The Nominating Committee shall consist of a chairman who shall be the immediate past president of the Society, the president-elect and three members in good standing. The three additional members shall have served the Society in some post of active participation such as having been an officer, member of the board of directors (elected or ex-officio) or committee chairman. If a member of the nominating committee is to be considered for nomination to any elective post, that member shall resign from the nominating committee and a replacement appointed by the president.

The Nominating Committee shall bring forth a slate of members of the Society who are in good standing for each of the posts of president-elect, vice president, secretary-treasurer, program chair, and at-large member of the board of directors. Any person so nominated shall have given his/her prior consent to nomination and election to such post.

The Nominating Committee shall submit its slate of candidates at least (90) days prior to the annual meeting in order that there will be time for submission of such to the membership for their consideration.

Additional nominations from membership or from the floor at the annual meeting shall not be permitted. However, a signed petition of 15 or more members entitled to vote may be employed to place a name on the ballot at any time prior to the vote.

B. Qualifications: Any member nominated for consideration shall be in good standing in the Society. While no absolute requirements exist for any post, the nominating committee shall consider factors such as duration of service (3 years for president-elect and at-large board members), balance on the board of directors (such as geographic, age, gender, sub-specialty qualifications) and the opportunity to increase the number and commitment of the members serving the Society. In general, it may be desirable to consider qualifications such as prior service to the Society and demonstrated leadership in the Confederation of Medicine as a requisite for nomination to the post of president-elect. Similarly, given the historic oversight by the vice-president of the granting of awards for research, a nominee for this post should have a suitable background in neurological research.

(If the above passes, the following will need to be changed:)

### Article III - Duties and Terms of Office Section 1 - Duties

E. Past President – The duties of the immediate past president shall be to serve as a member of the board of directors. He/she shall provide for the historian a written account of his/her term in office and shall serve as chairman of the nominating committee.


